THE RELEASED FILES ON BRUNEI AT THE NATIONAL ARCHIVES, UNITED KINGDOM IN 2008

1. Introduction

The National Archives has been acknowledged as one of the main institutions in the United Kingdom that preserved the files and records on Brunei. Most of these files and records had been released after 30 years of maturity and available for public to access and study. However, the files and records that are considered to be sensitive or contain controversial issues will be kept for more than 30 years and will be opened to a certain period decided by the institution concerned. Nonetheless, this is subjected to the earlier agreement and requirement by the institutions or agencies which created such files or records. Most of the files and records in this institution concerning Brunei are listed with hundreds of categories and accessible to the researchers as well as allowed for copying or purchasing subject to certain terms and conditions prior to any loan and purchase.

The files and records are generally catalogued by this institution according to the classes or series of records where they are listed. A standard reference consists of letters/numbers like FCO 15/218. For the most part of the files or records on Brunei can be accessed under the classification of Colonial Office (CO); Foreign Office (FO); Foreign and Commonwealth Office (FCO); Dominions Office (DO); Cabinet Office (CAB); Ministry of Defence (DEFE); War Office (WO); HM Treasury (T); Prime Minister's Office (PREM); and Air Ministry (AIR).

The research conducted by Brunei History Centre in 2008 focuses on Brunei released to the public from the covering dates between 1977 to 2008. There are 45 released files on Brunei, which include FO (14 files); FCO (11 files); DEFE (5 files); WO (4 files); OD (3 files); ED (3 files); CM (2 files); T (1 file); CAOG (1 file) and BW (1 file). Eight of those released files have been closed or retained by the National Archives. One of the file has been retained up to 70 years by the national archives even though they had reached 30 years of maturity specifically FCO 15/2186 (Leading Personalities in Brunei). This file will be released and opened to the public in 2048. The other closed files are FO 93/214/5 (Exchange of letters between the British High Commissioner and the Minister of Communication Brunei Darussalam, about Air Services between the Territory of the United Kingdom including Hong Kong and the Territory of Brunei Darussalam); FCO 15/2273 (Negotiations with Sultan of Brunei); FCO 15/2275 (Negotiations with Sultan of Brunei); FCO 15/2277 (UK policy towards Brunei); FCO 15/2187 (Political Relations between Brunei and Malaysia); BW 91/989 (Correspondence with Organiser of Technical Education and others dealing with recuritment matters and compilation of Notes for Newcomers, Brunei Independence, 1983, and termination of British Council/TETOC recruitment services); OD 70/30 (Brunei).

The researchers were able to study the released files particluarly FCO 15, FCO 24 and DEFE 24. These files include the subject of the negotiations talks between Brunei and Her Majesty Government (HMG) on the discussions of Gurkhas withdrawal in Brunei; the termination of 1959/1971 treaty agreements and the proposed new Treaty of Friendship and Cooperation; Brunei and Malaysia relationship; and Brunei Annual Review 1975 and 1976.

The documents of these files contain memorandums, letters, telegrams, minute of meetings, press released, cutting papers, drafts, notes and reports. Most of these files were studied and summarised. The summary of the documents are not comprehensive but it is useful as a preliminary reference for students and the public especially in writing the modern history of Brunei notably the history of Gurkha Battalion in Brunei and the process of negotiations talks in 1976 and 1977 until the successful signing of treaty of friendship and cooperation in 1978.
